FORM B: THERAPIST/COUNSELLOR AND APPLICANT INFORMATION FORM

The Patient Relations Program at the ADA&C follows the rules and regulations made into law by the Government of Alberta. This form is to be completed once the Applicant has chosen a therapist/counsellor and is required before funding can be provided by the ADA&C.
