

### **General Dentist & Specialist Application Requirements**

This application is for dentists who are **currently** or **were previously registered** in another jurisdiction within Canada, North America, or Internationally, and dentists who have completed a Specialty University dental program and/or the National Dental Examining Board (NDSE) process and will register their Specialty with the CDSA.

Dentists requesting registration as a general dentist for private practice, fee for service dentistry must complete the requirements of the *National Dental Examining Board* (NDEB) of *Canada* and the College of Dental Surgeons of Alberta (CDSA).

Dentists requesting registration as a Specialist dentist for private practice, fee for service dentistry must complete the requirements of the *National Dental Specialty Examining Board* (NDSE) of Canada and the College of Dental Surgeons of Alberta (CDSA).

All application information and supporting documents must be supplied electronically to <a href="Registration@cdsab.ca">Registration@cdsab.ca</a>. This includes notarized or certified documents.

Transcripts, Certificates of Standing, and Letters of Good Standing from other jurisdictions must be sent by email, directly from the source, to <a href="Registration@cdsab.ca">Registration@cdsab.ca</a>. It is the responsibility of the applicant to ensure all documents are supplied.

Documents are reviewed and processed in the order in which they are received.

The Registrations team will provide email confirmation of receipt upon review and the start of the application. Any additional information required will be outlined by email to the applicant. It is the responsibility of the applicant to ensure all documents are supplied.
